ADVERTISEMENT FOR BIDS
Southeast Guilford High School – Partial Re-Roofing Project

Sealed proposals will be received by the Guilford County School System until **1:00 PM, Tuesday, September 15, 2015**, at 501 W. Washington Street, Greensboro, NC 27401, Room 100, and immediately thereafter publicly opened and read aloud, to furnish all materials and labor for the Partial roof replacement of the Southeast Guilford High School project. Upon arrival, please check-in at the front information desk for room location, sign-in, and to obtain a parking pass for your vehicle. Please allow sufficient time for this, as late bids will not be accepted.

Plans, specifications, and contract documents in electronic format will be available for inspection and download **beginning 10:00 am on August 24, 2015**, until bids are opened, and at the following locations: North Carolina A&T State University Plan Room, Greensboro, NC; Associated General Contractors, Raleigh, NC; Minority Contractors Resource Center, Charlotte, NC; Reed Construction Data, Norcross, GA; Hispanic Contractors Association of the Carolinas, Winston-Salem, NC. A \$75.00 deposit is required to obtain a complete set of plans and specifications. The full deposit is refundable to contractors submitting a Bona Fide bid and returning the plans and specifications in satisfactory condition within 10 days of the bid date.

Plan Deposits should be made payable to Guilford County Schools and delivered to the office of Andre Johnson Architect located at PO Box 14637 Raleigh, North Carolina 27620. A brief description of work in the project follows:

Partial replacement of existing built up roofing system with new heat applied (torch) two ply SBS modified bitumen membrane roofing system for the Southeast Guilford High School. Roof section 11 over the gymnasium and auditorium shall be replaced totaling approximately 21,228 square feet of roof area.

A **non-mandatory pre-bid conference** will be held at the site at **10:30 AM, Thursday, September 3, 2015**. Attendees should meet at the **main administrative office of the school**. Bidders must be properly licensed for the work in accordance with Section 87 of the North Carolina General Statutes.

A 5% Bid Bond and 100% Performance and Labor and Material Payment Bonds are required for this project. No bid may be withdrawn after the scheduled closing time for the receipt of bids for a period of 60 days.

Minority businesses are encouraged to submit bids for this project. The appropriate forms from the section entitled "Participation by Women and Minority Owned Businesses" must be submitted with each bid to show good faith efforts to obtain Minority and Women Owned Business Enterprise participation.

The Guilford County Board of Education awards public contracts without regard to race, religion, color, creed, national origin, sex, age or handicapped condition as defined by North Carolina General Statutes, Section 168A-3. The Board reserves the right to reject any or all bids presented and to waive any informalities and irregularities.
