A brief description of work in the project follows:

Remove existing exterior steel sash windows & glazing in the auditorium where noted on the drawings. Install new aluminum sash, and insulated glazing, caulking, and repair to the adjacent plaster and paint if damaged during window installation.

Plans, specifications, and contract documents will be available at a **mandatory pre-bid conference** to be held at the site at **10:00 AM local time on Thursday, March 06, 2014.** Attendees should assemble at the **main office**. Attendance at this conference is required for all potential bidders to examine the existing conditions and to discuss particular details of the project. Bids will not be accepted from contractors that were not represented at this meeting by an employee on their payroll staff.

This project will be funded through the Qualified School Construction Bonds program, and will require the contractor to follow the Guilford County Schools ARRA reporting requirements as outlined in the General Conditions of the Contract for Construction included in the document package, Article 9.1.4.

Bidders must be properly licensed for the work in accordance with Section 87 of the North Carolina General Statutes. General Contractors must have a general license classification for at least LIMITED BUILDING in accordance with the Rules & Regulations of the North Carolina Licensing Board for General Contractors.

Bonding Requirements:

A 5% Bid Bond and 100% Performance and Labor and Material Payment Bonds are required for this project. No bid may be withdrawn after the scheduled closing time for the receipt of bids for a period of 60 days.
