- 7. Affidavit A. If the contractor checks box 1 or 7, back up must be submitted with bid
- 8. Appendix E must be submitted with all pay applications
- 9. Contractor to submit bid on Revised Form of Proposal provided with Addendum # 1
- 10. Contractor to submit Unit Pricing on revised Unit price page provided with Addendum # 1
- 11. Form of Proposal will include section to submit "Days to Complete" for both base and Alternate bid.
- 12. Skylights on roof area \$ are to be removed. Additional technical outline and details to follow with Addendum # 2

- 13. Are there Liquidated Damages. Please read the Guilford County Schools front ends for clarification.
- 14. TrueLo Max® Asphalt is the Asphalt of preference and to be included in the base bid
- 15. Low rise foam is acceptable cold adhesive
- 16. No addendum will be issues less than 5 working days from the bid due date
